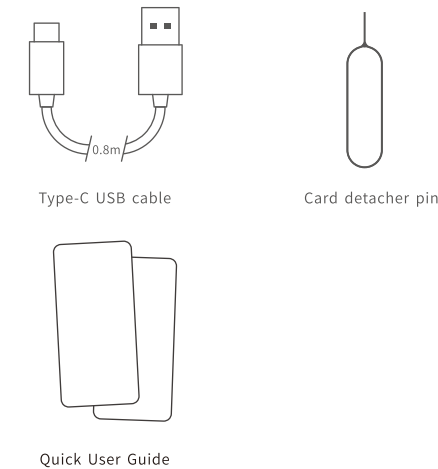

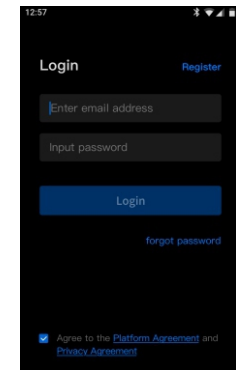
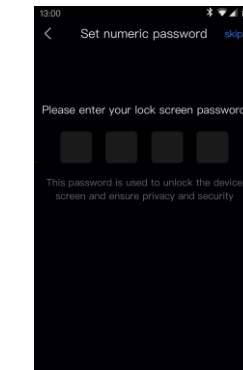
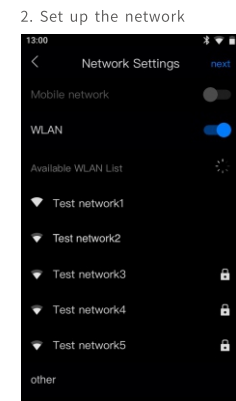
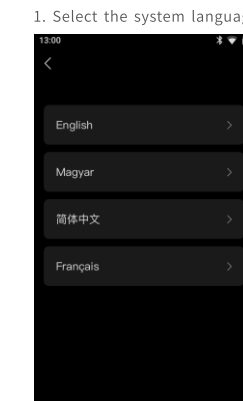


SIM card settings
